

## Claim Submission

### Acceptable Claim Formats

Durable medical equipment Medicare administrative contractors (DME MACs) accept Medicare claims both on paper using the CMS-1500 claim form and electronically. The CMS-1500 is one of the basic forms prescribed by the Centers for Medicare & Medicaid Services (CMS) for the Medicare Program. It is only accepted from physicians and suppliers that are excluded from the mandatory electronic claims submission requirements set forth in the Administrative Simplification Compliance Act (ASCA), Public Law 107-0105 and the implementing regulation at 42 *Code of Federal Regulations* (CFR) 424.32.

The current version of the form is FORM CMS-1500 (08/05) and is approved under the OMB collection 0938-0999. The CMS-1500 form is the prescribed form for claims prepared and submitted by physicians or suppliers, whether or not the claims are assigned.

Paper claims that are submitted with the old CMS-1500 claim form version 12/90 will be rejected.

**Note:** Acceptance of the CMS-1500 claim form (version 08-05) involves the paper claim form only. Suppliers submitting electronic claims are required to use the Health Insurance Portability and Accountability Act (HIPAA) compliant format.

### Claim Filing Time Limits

Medicare law prescribes specific time limits within which claims for benefits may be submitted. As a result of the Patient Protection and Affordable Care Act (PPACA), all claims with dates of services on or after January 1, 2010 must be filed within one calendar year after the date of service.

- Claims with dates of service prior to October 1, 2009 must be submitted by December 31, 2010.
